
Surge In Burials Means Longer Waits for Interment Dates

When a loved one passes, the last thing families want to hear from the cemetery is that the first available burial date is more than a month out. It is also the last thing that cemetery staff want to tell grieving families.

Prior to and throughout the first months of the pandemic, the Orange County Cemetery District was able to quickly accommodate requests for burial, particularly from those whose religious or cultural practices required rapid interment. In 2019, a typical month at El Toro Memorial Park would see anywhere from 45 to 55 interments. El Toro's busiest month in 2019 saw 68 interments. Since July of 2020, El Toro's service numbers have consistently been in the 70's with January 2021 coming in at 88 interments.

But those numbers don't tell the full story. Staff at El Toro are now conducting interments seven days a week and have even started to schedule some burials on holidays. We have increased weekday services from three to four a day to try to keep pace with the need. In order to fit four services in on one day, we are asking families to limit graveside services to no more than 30 minutes. But even with those measures, there are simply more families needing burials, then there is time to conduct the interments. After scheduling the maximum number of burials that can be squeezed into one day, the only recourse is to push interment dates further out. In early February, the first available interment dates were being scheduled for early March.

This wave of deaths is impacting every facet of the funeral industry, including mortuaries and even our cement vault suppliers. In January, we

were notified by our main vault supplier that they could not keep pace with the demand. After calling every cement vault vendor we could locate in Southern or Central California, we found the same problem impacting every company.

Fortunately, we were able to locate a company in Georgia that makes polypropylene vaults guaranteed to last 50 years. The District was able to secure an order of 60 vaults to tide us over until the local vault companies can catch up.

As we approach the end of February, the need has not decreased. We are estimating that El Toro Memorial Park will conduct

86 interment services in February. As the vaccines become more widely accessible it is our hope that the worst is

Community Support for a New Public Cemetery Needed Now

Several years ago, Anaheim Cemetery sold its last available casket interment space. In 2020, Santa Ana Cemetery also sold its last available casket space. El Toro Memorial Park is now the last public cemetery in Orange County with available space for casket burial. At the accelerated rate of sale we have experienced over the last few months, the District estimates that El Toro Memorial Park, also, will be sold out for full casket space in four to six years.

Why does this matter? If you have a loved one buried at one of the County's three public cemeteries you know first-hand, the economical advantages the Orange County Cemetery District offers to families. If El Toro Memorial Park sells out of casket space, and no fourth public cemetery is established, the ability to have a casket burial for your loved one will also disappear for thousands of our neighbors and fellow community members. The unfortunate fact is, that casket burial at private cemeteries, is either completely out of reach or at best, presents a tremendous financial burden for most people.

When public cemetery districts were first established in Orange County, it was because the public believed in the importance of maintaining and preserving the final resting places of its citizens in a dignified and respectful manner. A small portion of property taxes goes to the support of these cemeteries so that they are able to offer County residents the most affordable interment options possible.

With the help and foresight of the County of Orange Board of Supervisors, 283 acres of raw land in Gypsum Canyon was transferred to the District in December of 2018. The District received the land under the condition that 50% of the developable acreage be reserved for a State Veterans Cemetery and contingent upon the public cemetery conducting its first interment with ten years.

Since that time, the Orange County Cemetery District has spent over \$600,000 in site assessments, geotechnical surveys, preliminary site designs, and traffic studies. Preliminary cost estimates for infrastructure such as road construction, utilities, and site grading come in at about \$17 million. The first phase of public cemetery development is roughly \$35.6 million. Even with the \$11.3 million that the District has diligently saved over the last decade, total project costs of \$52 million exceed the District's financing ability. The District is currently looking at the design, to determine if any changes can be made to lower the costs for the first phase of public cemetery development.

If this project is going to move forward, we will need the continued support of the Orange County Board of Supervisors and approval from the City of Anaheim that has jurisdiction over the land at Gypsum Canyon. They must be made aware that the continuation of public cemeteries in Orange County is a priority for its current citizens as well as a necessity for future generations.

Garden of Innocence Service Scheduled for March 20th at 10:00 a.m. Help Us Honor and Remember Wyatt, Grace and Faith

Garden of Innocence is a nonprofit organization dedicated to the respectful interment of abandoned or unidentified remains of children. Since opening the El Toro Memorial Park Garden in 2016, 16 little lives have been laid to rest.

Due to the surge in burials that have been occurring since December, the Garden of Innocence Service at El Toro Memorial Park for Wyatt, Grace and Faith originally scheduled for January 23rd, had to be postponed. A new service date has now been scheduled for Saturday, March 20th at 10:00 a.m.

Services usually include a procession by the Knights of Columbus, a guest speaker, special music and poetic readings.

If you attend, please remember that COVID safety guidelines will be enforced. We ask that all attendees maintain a six-foot social distance from those they do not live with. Everyone must be wearing a protective face covering. Please bring your own chair if you require seating, as the cemetery cannot provide chairs at this time. Flower Removal and Holiday Schedule

Every Wednesday, groundskeepers remove and discard flowers and decorations throughout all three cemeteries. Families are encouraged to remove their flowers and/or decorations on Tuesday night. You can then place the flowers back on the space on Wednesday afternoon. Please remember that the District policy only allows for two items to be placed on gravesites. This includes the inground flower vase and one other item. If gravesites exceed the number of allowed items, staff may remove and discard the excess items. Please do not leave items of great monetary or sentimental value on gravesites as the District cannot prevent theft.

Throughout the year, various holidays are recognized with extended periods between flower clean-ups. During these times, we do ask that you empty the vase and place fresh water in the container every four to five days to eliminate mosquito breeding sources, which can cause serious health issues. Your cooperation in this regard is greatly appreciated.

In honor of Persian New Year and Easter, flowers may be placed at El Toro Memorial Park on Thursday, March 11th and must be removed by Tuesday, April 13th. Flowers may be placed for Easter at Anaheim and Santa Ana Cemeteries on Thursday, March 25th and must be removed by Tuesday, April 13th.

Flowers for Mother's Day may be placed at all District Cemeteries beginning on Thursday, April 29th and must be removed by Tuesday, May 18th.
