

Revenue Projection Factors

- Staff review of projected interments and services based on past 2 years
- Reduced the total interment sales & services due to diminishing inventory and restrictions at El Toro Memorial Park
- Current Secured Property Tax increase of 3%
- Factored a 3% increase in Lease Payment for Cell sites
- Interest estimating a slight decrease due to potential drop in rates



Expense Projection Factors

- Merit increase factored for all employees due to a 2.5% range adjustment some employees may receive 5.0%
- Total salaries is reduced by \$35,501, due to a reduction in overtime and based on changes to two positons
- OCERS Employer Contribution Rate is 15.12% (Legacy Emp.) and 14.49% for employees hired after January 1, 2014. This includes a 2.45% UAAL Rate Component
- Total Retirement Benefit is reduced by \$25,502, due to implementation of new Health Reimbursement Arrangement for retiree medical plan and deferred compensation participation
- Economic Uncertainty (5% of total S&B and S&S) \$249,106
- Overall services & supplies budget is reduced by \$221,873, due reduction in liability insurance, maintenance services at the existing and new cemetery grounds and small tools.
- Purchase of \$197,300 in equipment due for replacement, which includes one piece of equipment ordered in 2023-24.






