Well Inspection and Repair Scheduled at Anaheim Cemetery

In late November, staff at Anaheim Cemetery noticed issues with the groundwater well pump operation. It appeared that the pump motor had seized up and there were minor leaks around the pumphouse. Our well service technician came to investigate and determined that the pump and potentially the well shaft were damaged.

Unfortunately, a well and pump contractor would be required to provide further analysis. Staff met at the site with Fain Drilling and Pump Company who determined that they will need to bring in a large crane to lift the pump/well head out of the pumphouse through the hatch located on the roof. More than likely, 300 plus feet of the shaft will also have to be removed, which will come out in 20-foot sections.

The contractor was planning to begin during the week of December 16th-20th, however there were concerns about the proximity of the Public Utilities (APU) Anaheim electrical service lines to the pumphouse hatch. The electrical lines and poles are located in the temporary sprinklers to irrigate

backyard of the residences next to the pump house. The contractor and staff have been in contact with APU to coordinate a more extensive action plan to ensure everything is safe throughout the removal and replacement of the pump and shaft.

We anticipate that the removal and repair work will begin during the week of January 13th-17th. Once the pump and the sections of shaft are removed. the contractor determine how to make repairs. We anticipate that the well will be back in service by March 1, 2025.

Since the groundwater well was down, the automated irrigation system, along with the hose bibs were not active, thus no water was available to irrigate the lawns and for families to fill up their flower vases. Initially, the Cemetery Manager and staff placed buckets filled with water (from the hose bib located by the office), around the grounds so that families could get water for their flower vases. addition, several sections of hose were laid out to set up some

areas that were getting dry. were fortunate that it is winter and temperatures are cooler. though we have not had any rain.

Shortly after this, our irrigation team worked with a water line contractor to set up a temporary connection to the City water, through a temporary meter located on the fire hydrant in front of the cemetery. Once the temporary connection was made to the irrigation system, our Irrigation Technician was able to turn on the automated irrigation system and began to irrigate the lawns, trees, bushes and rose gardens.

We appreciated your understanding while the water was off. The groundskeepers will make every effort to get the grounds back in shape. When Fain begins the removal and repairs, there will certainly be some inconveniences while you are visiting, such as limited access to certain areas and equipment noise. We appreciate your patience during this time and apologize in advance for any inconveniences the repair work may cause. Thank you!

El Toro Repaints Red Curbs and Section and Block Indicators



In early November, a contractor was hired at El Toro Memorial Park to repaint the red curbs and stencil new section and block markings throughout the grounds.

With multiple services taking place each day coupled with a high volume of visitation, it is essential that everyone abide by the red curb parking restrictions. This will help to prevent roads from becoming

blocked due to people parking on both sides of the street and it will also ensure that emergency vehicles will be able to quickly access all areas of the park if needed.

You will also notice the newly repainted section and block markers on the streets. This will make it easier for visitors to identity what lawn they are at and where the block breaks are occurring.

Flower Removal and Holiday Schedule

Every Wednesday, groundskeepers remove and discard flowers and decorations throughout all three cemeteries. Families are encouraged to remove their flowers and/or decorations on Tuesday night. You can then place the flowers back on the space on Thursday morning. Please remember that the District policy only allows for two items to be placed on gravesites. This includes the in-ground flower vase and one other item. If gravesites exceed the number of allowed items, staff may remove and discard the excess items. Please do not leave items of great monetary or sentimental value on gravesites as the District cannot prevent theft.

Throughout the year, various holidays are recognized with extended periods between full park clean-ups. During these times, we ask that you empty the vase and place fresh water in the container every four to five days to eliminate mosquito breeding sources, which can cause serious health issues. Your cooperation is greatly appreciated.

In honor of Chinese New Year, flowers may be placed on Thursday, January 16th and must be removed by Tuesday, Feb. 4th. Flowers may be placed for Valentine's Day beginning on Thursday, Feb. 6th and must be removed by Tuesday, February 25th. During this time, light clean-ups will still occur each Wednesday and only flowers that are obviously wilted will be removed.

During full park clean-ups everything on gravesites are discarded. Please be sure to remove items you do not want discarded before the cemetery closes on Tuesdays.
